# MONTENOTTE LEISURE CLUB RULES

The Club will be called 'The Owner' and shall be administered by the Manager of the Club (the Manager) or by such persons as the Owner shall nominate.

1. Persons wishing to become members shall complete the official application form. Applicants are requested to submit the form duly completed to the Manager.
2. Each application form must be accompanied by payment in respect of the appropriate annual subscription. Direct Debit payment can be made by prior arrangement. Membership subscriptions are non refundable.
3. On acceptance of an application, the applicant will receive a membership card which will remain the property of the Owner and upon termination of the membership for whatever reason will be returnable to the Owner on demand. Absolute discretion is granted to the Owner or Manager to reject an application or renewal of membership, and in such cases any monies sent will be immediately refunded.
4. Annual subscriptions and charges for individual facilities shall be such amounts as the Owner in its sole discretion shall determine from time to time.
5. Membership cards are non transferable. Each member shall be entitled to be accompanied by not more that two guests and shall be responsible for the appropriate charge (as specified by the Manager) for such guests use of the facility.
6. The times at which any or all of the facilities shall be available to members and guests shall be at the discretion of the Manager, as is any or all right to limit the periods of time and number of persons using any area in the centre.
7. Guests must be accompanied by a member and must sign the guest book. Membership cards must be shown at all times. A member introducing a guest shall be responsible for the good conduct of such guests while on the premises.
8. Sauna, Steam Rooms and Jacuzzi are available. Instructions are posted in plain view in the area. The Owner or management shall not be liable for the consequences of any persons failing to follow the instructions.
9. The right is reserved to make and or vary such rules and regulations in relation to the use and operation of the centre as the Owner and/or Manager may consider necessary. All members shall comply fully with such rules and regulations as may be enforced from time to time.
10. The Owner and/or Manager may terminate any persons membership in the event of the breach or non-compliance by such member with the rules as specified herein or as made by the Owner/manager from time to time.
11. Children under 16 may use the facilities as specified by The Manager but do not have access to the Gymnasium, Sauna, Steam Rooms or Jacuzzi. All children under 14 must be accompanied by an adult at all times.
12. The appropriate attire (relating to the specific activities) must be worn at all times.
13. All persons using and availing of facilities do so entirely at their own risk. Owner or Management do not accept liability for loss, damage or injury.
14. Direct Debit Information: Please note that Direct Debits will run on a continuous basis, month by month and year by year, until such time as we receive notification of cancellation.
